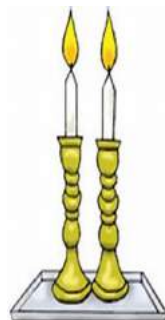

1. There is NO ADDITIONAL CHARGE for books and materials.
2. If more than one child is enrolled, there is a tuition discount of \$50/child for the younger sibling(s). **This discount is not available to siblings enrolled in the Pre-K class, to children of non-members or to JAO students.**
3. For JAO students in Grades K through 4, tuition is only 50% of the rates shown above.
4. Non-members may enroll their children in Pre-K through Grade 4 for only one year. After that, CBA membership is required to re-enroll children. **Membership is required to enroll children in grades 5-7.**
